Diana joined CWDA in 2005 as a Senior Policy Analyst and was promoted to Director of Policy for Child Welfare and Older Adult Services in January 2019. She specializes in the program areas of In-Home Supportive Services, Adult Protective Services, Child Welfare, and Foster Care. Previously, Diana served as a program planner/specialist for Sacramento County Department of Health and Human Services, and as legislative analyst and director of governmental relations for Santa Clara County Social Services Agency.

Kim Rutledge, M.S.W, Adult Protective Services Liaison, California Department of Social Services Kim was appointed Program Liaison for Adult Protective Services (APS) at the California Department of Social Services in 2019 where her duties include enhancing statewide policies and procedures to promote consistent statewide APS practices, and strengthening and expanding services to meet the needs of vulnerable older and dependent age adults. She is the CDSS ex officio representative to the State Independent Living Council, and represents the department on the CalSWEC Advisory Board as well as in the Silence = Violence Network, a stakeholder workgroup created to bring advocates together to increase public awareness around elder and dependent adult abuse. Before coming to APS, Kim served as the Chief of the Policy and Quality Assurance Branch within the CDSS Adult Programs Division for three and a half years, overseeing policies impacting the In-Home Supportive Services program and the Deaf Access Program.

Carol Sewell, M.A, Legislative Director, California Commission on Aging

Carol is a past chair of the Chair of the California Elder Justice Coalition (CEJC) and Legislative Director for the California Commission on Aging (CCoA). She is also on the Gerontology faculty at CSU Sacramento. As the CCoA's legislative advocate for over 14 years, she has helped to secure increased funds for low-income senior housing, developed legislation requiring mental health practitioners to recognize and report suspected elder abuse, and worked to increase funding for APS training and the Long-Term Care Ombudsman. In partnership with CEJC and CWDA, she helped to establish the State's first Adult Protective Services (APS) liaison position at CDSS. Prior to her work with the Commission on Aging, Ms. Sewell worked for over ten years as a legislative aide in the State Assembly and as a policy analyst for Governor Gray Davis.
