Integrating Peer Supporters into Mental Health and Substance Use Medi-Cal Systems of Care



This training will focus on multiple aspects of bringing peer supporters onto a behavioral health team in any type of service. This course will begin with an overview of what is meant by peer support and a review of who qualifies as a peer supporter under California guidelines. There will also be an overview of services that peer supporters can provide: which are Medi-Cal billable and which may not be but are still important. Participants will engage in various activities addressing different scenarios, cooperate in small groups to identify solutions to specific workplace situations and have time to share concerns, questions, and successes in a collaborative, welcoming, and open environment.
