Evaluation Part II: Turning Quality Measurement into Quality Improvement



This is the second workshop of the evaluation series with presentations by leaders in Washington State APS and APS quality assurance (QA) systems. In January, the presenters walked through how to develop or enhance key performance indicators for your county programs. But what happens after that? How you will use the information is instrumental in how you communicate about the process with your staff and how your QA efforts will better support your teams through structural changes, training, and policy updates.

This is valuable as a stand-alone workshop! It delves deeper into Washington State's Quality Management System – the steps used to turn data into information and information into understanding and that understanding into action for improving the system. The presentation will cover differences between the symptoms of a problem and its causes, and how to address those "root causes."

Our *panelists* shared the Washington State experience at the 2023 NAPSA conference and their thoughtful approach toward quality improvement resonated with attendees from across the country. Our *moderators* will help tie the Washington experience to counties across California. Our *breakout sessions* will group counties with a mixed level of experience to share their goals, ideas and questions about quality assurance processes. Whether you have a QA system in place currently or not, this workshop will focus you on the fundamental goal – how to use QA to better meet the needs of adults who experience, or are risk of, maltreatment.
